NOTICE TO ALL KNOWN CREDITORS AND OTHER AFFECTED PERSONS OF THE APPOINTMENT OF PHAHLANI MKHOMBO AS THE BUSINESS RESCUE PRACTITIONER IN THE BUSINESS RESCUE PROCEEDINGS OF SAFFER PLUMBING AND HARDWARE PROPRIETARY LIMITED (“THE COMPANY”) IN TERMS OF SECTION 129(4)(b) OF THE COMPANIES ACT 71 OF 2008

1. This notice follows an earlier notice, addressed by the company in accordance with the provisions of section 129(1) of the Companies Act 71 of 2008 (as amended) (the **Companies Act**), in which you were notified that the board of the company adopted a resolution on 23 July 2020 to voluntarily commence business rescue proceedings. The board of the company also resolved to appoint Mr Phahlani Mkhombo (**Mr Mkhombo**) as the business rescue practitioner of the company.
2. Mr Mkhombo accepted the appointment. A Form CoR 123.2 – Notice of Appointment of Business Rescue Practitioner – was filed with the Companies and Intellectual Property Commission (“CIPC”) on 23 July 2020. Mr Mkhombo’s appointment was confirmed or endorsed by the CIPC via an email on 29 July 2020. A copy of the email confirming or endorsing the appointment of Mr Mkhombo is attached marked as Annexure A for ease of reference.
3. A copy of the Form CoR 123.2 – Notice of Appointment of Business Rescue Practitioner – is attached to this notice in accordance with section 129(4)(b) of the Companies Act. Also attached is Mr Mkhombo’s acceptance of the appointment.
